She has authored several articles and presented at national conferences on this topic. Her research also includes the impact of race relations on Christianity and the examination of structural oppression and its impact on vulnerable populations.

Diana R. Garland received her BA, MSSW, and PhD degrees from the University of Louisville. She is Professor of Social Work and inaugural Dean

of the School of Social Work, Baylor University, Waco, Texas, where she has served on the faculty since 1997. She previously served as Dean of the Carver School of Church Social Work at The Southern Baptist Theological Seminary in Kentucky. She is author, co-author, or editor of 18 books. The most recent are *Inside Out Families*; *Living the Faith, Together* and *Flawed Families of the Bible: How God Works through Imperfect Relationships*. The second edition of her book *Family Ministry: A Comprehensive Guide* (InterVarsity Press) is forthcoming; previously, it won the 2000 Book of the Year Award of the Academy of Parish Clergy at Princeton Seminary. She has published more than 100 professional articles and book chapters. She has received more than \$7 million in research and program grants since coming to Baylor in 1997, from organizations such as Lilly Endowment, Inc, Pew Charitable Trusts, Inc., the Annie E. Casey Foundation, the Henry Luce Foundation, and the Ford Foundation.

Helen Wilson Harris earned a BA from the University of Mary Hardin-Baylor in Belton, Texas, MSW from Our Lady of the Lake University in San Antonio, Texas and Ed.D. from the University of Mary Hardin-Baylor. Presently she is a Senior Lecturer at the Baylor University School of Social Work where she teaches across curriculum. Previously Helen served as Director of Graduate Field Education and Director of Field Education for ten years. Prior to coming to Baylor, Helen was the founding director of the first hospice in central Texas and served for eight years as foster care and independent living director at The South Texas Children's Home. He serves on the editorial board of *Social Work and Christianity*. Dr. Myers was recognized as a Distinguished Teacher by the Association for Gerontology in Higher Education and as an expert Gero-Ed Center Expert Trainer by the Council on Social Work Education. He is the principle investigator for the Danny and Lenn Prince Initiative for Quality Long-term Care with Older Adults that provides research, evidence-based practice models, educational programs, and practical resources to strengthen the care environment of residential facilities and to enrich the personal and family life of older persons who reside in them. He is also the co-principal investigator for the Bilingual Mental Health Scholarship Program for Accredited

Social Work Programs, funded by the Hogg Foundation (2008-2013). During the period between 2002 to the present, Dr. Myers authored or co-authored 26 journal articles in the areas of social work practice, educational gerontology, adult caregiving, productive aging, and faith-based community services.

Presently, she is associate professor and field coordinator at Malone University in Canton, Ohio.
