The Story of Moses

"We make the path by walking it."

Exodus 33:13 "Show me your ways."

Exodus 13:21 "Follow this cloud."

Calling

"" Calling" is the sense that God or some other presence beyond oneself compels one to take a particular direction; the direction is not simply a matter of choosing based on one's own motivations and preference' (p. 210).

They Did Not Know Where They Were Going

- These social workers did not know they would be in a context of practice that was called congregational social work.
- They understood their calling by looking back to the path they had already walked.
- "This is what God has called me to do."

A Spiritual Sense of Calling

- "Locus of inspiration" -- being inspired to become social workers
- Being called to a Christian vocation
- Social work as a vocational Christian calling -- NOT
- "God called me." (providential?)
- Experiences at youth camp or service activities
- ▶ Being a client

Calling Confirmed by Evidence

- The right place "I've been called to this work, and God has chosen me" (p. 216).
- <u>The right gifts</u> "God equipped me personally. He designed me to be a social worker" (p. 217).
- <u>Other paths</u> "calling" reflects a call to their work and may not be centered in spiritual language.

Unfolding Paths

► Social worker in other settings

- From congregational leadership in other than social work positions
- ▶ From congregational membership
- Congregational path to readiness " pastors hired them with lots of hope but little understanding of what they could do" (p. 222).

Professional Preparation

Departments/schools of social work

-- most had no preparation for working in congregations

-- adapted what they were taught

-- felt prepared for generalist practice & the wholistic nature of social work was an asset

"I wouldn't be doing what I'm doing if I hadn't had that field placement" (p. 224).

Professional Preparation

- ► Continuing education
- Mentoring and consultation
- Preparation not received
 Little or no focus in social work classes on congregations
 - -- Wish there had been, or had more, opportunity for discussion about congregational contexts
 - Expressed the need for more integration of spirituality/religion in social work education.






- 1) Professional isolation

- 8) Deciding when to attempt change (p. 231)


Being a Congregational Social Worker
